# COMMUNITY MEETINGS

During 2022, GLAHR organized 43 weekly hybrid meetings where members gather to learn and discuss policies, and/or issues related to the immigrant communities with an average of 30-40 people each time from the Atlanta area and other parts of the state.



# FOREST PARK IN RESISTANCE



Our outreach efforts continued in Forest Park under the campaign known as “**Forest Park in Resistance**”. The community organizing work is directed to -end racial profiling – that targets Latinx community in the city and county. In a period of four months of canvassing and tabling, GLAHR was able to reach 221 community members and contact more than 330 via phone calls and text messages and organized a community meeting.





In 2022 GLAHR formalized efforts to expand organizing work in South Carolina, although a comité popular was already established in Hardeeville, SC.

The SC Collective-GLAHR organized 5 community meetings with volunteers and members and provided 6 workshops ranging from the types of government, the importance of voting, and social media.

As part of the activities organized to gather attention and community participation, the SC Collective held 4 events: Mother's Day, Father's Day, Art Day, and the day of the children (El día del niño).






Since the new project was launched in February 2022, we have been able to hold 47 canvassing and tabling events and reach 1,104 individuals.




# ASAMBLEA POPULAR




# THE BLOCK

GLAHR organized ten civic engagement educational workshops to members and staff in preparation for the midterm elections.



For the second time, GLAHR organized an initiative called the "Election Defenders," where more than 78 individuals came together to travel 80 precincts throughout Georgia in observance on primaries election day, making sure no incidents are taking place when individuals exercise their right to vote and provide help if there is a need. While in the runoffs, we nearly doubled the number of "Election Defenders," reaching over 100 precincts within 16 counties throughout Georgia.

As part of GOTV outreach in South Georgia, the GLAHR team canvassed 14,403 doors in 33 South Georgia Counties: Lanier, Lowndes, Cook, Dodge, Wilcox, Crisp, Dooly, Turner, Ben Hill, Tift, Telfair, Irwin, Berrien, Echols, Candlerand, Brooks, Clinch, Seminole, Grady, Bacon, Early, Miller, Baker, Mitchell, Worth, Charlton, Ware, Thomas, Pierce, Long, Brantley, Colquitt, and Coffee counties.

# GOTV: LA GENTE VOTA



Our team in Southeast canvassed the coastal region of Georgia, reaching out to 10,115 doors in 19 Southeast counties. Including Chatham, Bulloch, Montgomery, Treutlen, Wheeler, Evans, Effingham, Telfair, Jenkins, Screvens, Candler, Toombs, Tatnall, Washington, Jefferson, Johnson, Glascock, Burke, Emanuel, and Savannah, Ga. to inform the immigrant communities of immigration changes and the importance of voting.

# LEGISLATION

During the first half of 2022 GLAHR participated at Ga State Capitol against ill legislation that aimed to criminalize peaceful protests (SB171), gives the GBI election power to audit the election results (SB441), and censor race and ethnicity (SB377, HB1084). While also fighting for the end of Corporal Punishment in the state (HB 892 and HB 904), in collaborative work with Project South, Alliance for Black Lives, Georgia Youth Coalition, Progress GA, America Votes WWA, The People's Uprising, and NAACP. Along with the coalition.



# LEGISLATION



GLAHR participated in 39 calls regarding newly introduced bills, updated legislation, strategic planning, and 14 calls to action, including calling representatives, giving testimony, and rallies.

# IUPAT



GLAHR participated with the International Union of Painters and Allied Trades (IUPAT) in 3 events against companies who have not compensated, mistreated, and ignored their workers when they are not being heard and represented. We have joined the IUPAT in 4 national calls and a summit to continue our collaboration.



# WOMEN ON THE RISE: COMMUNITIES OVER CAGES



As co-anchors of the Communities over cages campaign, GLAHR participated in **46 strategic calls** and **5 calls to action**, including giving testimony, rallies, and calling/emailing city council members against continue utilizing Atlanta City Detention Center as an extension to the Fulton County Jail.

Unfortunately, the Atlanta City Council voted to allow over 700 beds to alleviate the overcrowding in the Fulton County Jail.

# GEORGIA DETENTION WATCH

In our efforts to #ShutDownICE and #FreeThemAll, we have been able to strategize efforts to push shut down the remaining three detention centers in the state in collaboration with Project South, GDW, SPLC, and GHRC, among other organizations, submitted FOIAs, and CRCL complaints. We have been able to meet 20 times with members of Georgia Detention Watch.

GLAHR and partner organizations exposed the sexual assault that four women went through while detained at Stewart County Detention Center, located in Lumpkin, GA.







In collaboration with the Unitarian Universalists, GDW, Project South, and Side with Love led a protest in front of Folkston ICE Processing Center against its expansion that will increase available beds. We were joined by We are Home, SPLC and other individuals who are also part of the movement.

As a result of our work alongside Project South, GDW, and South Georgia Immigrant Support Network, the permanent subcommittee on Investigations was able to hear the testimony of one of the victims of the forced hysterectomies.

# GEORGIA IMMIGRATION BOND FUND



The Georgia Immigration Bond Fund has assisted **18 families** in reuniting with their loved ones; in doing so, GLAHR, as its hub, has posted bonds ranging from \$3,000 to \$12,000. The Georgia Immigration Bond Fund has paid **\$149,540** in bonds.



# LEGAL HANDLES: DACA/PETITIONS

GLAHR was able to help community members complete **29 DACAs**, submit **22 FOIAs**, and assist members with **32 requests and services**.

In partnership with Advancement Project, GLAHR and other concerned organizations and individuals participated in a lawsuit against the state of Georgia and the Secretary of the state, Brad Raffensperger, regarding **SB 202**. Unfortunately, the first leg of the lawsuit that criminalized “handing food and water” to voters was denied in this upcoming election.

# STAFF TRAININGS/ HEALING & MINDFULNESS

GLAHR staff participated in **56 workshops** centered around mindfulness, race and mobility, Management, immigration law, gender constructs, Quickbooks 101, and accounting.

Also, GLAHR organized **3 Staff retreats**, two of which were led by long-time organizers focused on reflections on the task of an organization, the style of work, and the organization's work plan. GLAHR staff learns about the importance of protecting the vote, the Latinx history in the state, mobilizing vs. organizing, redistricting, and civic engagement. GLAHR Staff-women participated in **5-day Mindfulness workshops**, and 5 staff members received individual support.

# GRASSROOTS FUNDRAISING





# DIGITAL COMMUNICATIONS/ SOCIAL MEDIA


The Georgia Latino Alliance for Human Rights (GLAHR) and its Executive Director Adelina Nicholls have featured *79 news articles* about legislation, the 287g program, grassroots organizing, Stewart Detention Center, and Folkston's expansion.

GLAHR social media reached **241,152 individuals** via Facebook, Twitter, and Instagram. Posted more than **179 photos, 77 videos, 93 Twitter posts, and 90 stories**, all of which dealt with GOTV, upcoming events, *#ForestParkinResistance*, *#FreethemAll*, *#GalmigrationBondFund*, detention center, changes in legislation, and calls to action.

The communications team was able to participate in **one marketing course** that included 12 lessons while also attending a Digital Ad webinar.

GLAHR's communications coordinator participated in a **senior narrative cohort** on power building, cultural work, and electoral organizing workshops.

The communications team facilitated **two training sessions**, one for the South Carolina Collective and one for Latino Community Action in Athens, Ga.
